COURSE OVERVIEW/DESCRIPTION :

This course provides an overview of the various forms of alternative dispute resolution mechanisms –negotiation, mediation, arbitration, and their hybrid forms. Theoretical discussions will be supplemented with in-class simulation exercises. About a third of the classes will focus on the latest development in ADR including the presentation and discussion of your research topics.

- Appreciate how psychology affects the dispute resolution process
