Spring 2022 Registration Information for First Year JD Students

First year JD students will use PatriotWeb (https://patriotweb.gmu.edu) to register for their spring courses beginning on November 23, 2021, at 9:00 a.m. Although first year students follow a pre-set schedule, the process of registering will allow students to become familiar with how to use the PatriotWeb registration system.

In addition, the law school offers a Winter Term in conjunction with the Spring 2022 semester. Winter Term courses are considered part of the Spring Semester. All first-year students are required to take the LRWA II programming during Winter Term. Some Winter Term courses are open to first year students if they do not conflict with LRWA II.
