## **Learning Outcomes**

The principal goals of the class are for students to acquire a solid working knowledge of competing approaches to constitutional interpretation (e.g. – originalism and living constitutionalism), the Supreme Court's jurisprudence on major issues of federalism and separation of powers, and how the relevant legal doctrines have developed over time.

## Assignments

Although I will try to stick to the schedule, we may occasionally fall behind. In such an unfortunate case, we will begin the next class with the next case or other reading on the syllabus, unless I say otherwise.

Note: In a few cases, I may have included a complete case or article in the packet, but the syllabus indicates specific pages for you to read. You are only responsible for the pages noted in the syllabus, though you may wish to skim the rest. Pages noted in the syllabus refer to page numbers in the US reports or Supreme Court reports (for cases) or journal (for articles), NOT to other page numbers that may be present.
