numbers in the US reports (for cases) or journal (for articles), NOT to other page numbers that may be present in the packet.

Learning Outcomes

Students will become conversant with different approaches to statutory interpretation, such as textualism and purposivism, the pros and cons of reliance on legislative history, and a variety of canons of interpretation utilized by courts. They will also learn different theories of the legislative process and become familiar with competing perspectives on statutory interpretation developed by judges and legal scholars.
