Student Learning Outcomes/Objectives:

- Students will learn the intellectual history of the administrative state and how it became largely independent of the "checks and balances" that apply to other branches of government.
- 2. Students will review opinions, briefs and oral arguments in several pending Supreme Court cases reconsidering key aspects of the administrative state, including deference to agency determinations and the absence of jury trials.
- 3. Students will consider critically various strategies that have been proposed to "rein in" the administrative state, including the non-delegation doctrine and expanded powers of the president to fire subordinates.

Grading: Students will have the option of either submitting a paper on a topic of their choice related to the course or taking an essay exam. This written work with account for 80% of their grade, with class participation accounting for the other 20%.
