THE MASTER OF LAWS (LLM) IN CYBER, INTELLIGENCE AND NATIONAL SECURITY LAW (CINS) prepares graduates with the expertise to navigate the emerging policy, legal, and constitutional issues in these key areas. The program leverages the expertise and knowledge of GMU's National Security Institute (NSI) to produce graduates equipped to work for government agencies, law firms, businesses, and public interest and policy organizations that are tackling the issues created by an increasingly connected and data-focused world.



Learn from expert faculty who work on core national security missions and build and implement some of the most influential legal and policy frameworks governing our nation's military and intelligence activities.

Scalia Law offers the most cost-effective option for LLM study in the D.C. metro area, and is minutes from the heart of the nation's capital and the nation's highest concentrations of technology companies, government contractors, and national security and intelligence agencies.

Through NSI, students can engage with over 170 national security experts that comprise NSI's Advisory Board, Faculty, and Fellows, including former Directors and General Counsels of the CIA, DIA, NSA, DoD, NGA, and ODNI and leaders and entrepreneurs in private industry.

Who Benefits from a CINS LLM?

ARMED FORCES

Lawyers, civilian or military, who support the branches of the U.S. military.

CONGRESS

Lawyers who counsel members of the U.S. House of Representatives, the U.S. Senate, and the national security-related Congressional committees.

GOVERNMENT AGENCIES

Lawyers who support the national security missions of agencies such as the Department of Defense, the Department of Energy, the Department of Homeland Security, the Department of Justice, the Department of State, the Department of the Treasury, and others.

INTELLIGENCE COMMUNITY

Lawyers who support the U.S. Intelligence Community, including the Office of the Director of National Intelligence, the Central Intelligence Agency, the Defense Intelligence Agency, the Federal Bureau of Investigation, the National Security Agency, and others.

PRIVATE SECTOR

Lawyers who practice at law firms, in-house, or as consultants and advise their clients on cyber, intelligence, and national security matters.

PUBLIC INTEREST AND POLICY PROFESSIONALS

Lawyers who work for organizations that advocate for policies relevant to the cyber, intelligence, national security law.



THE NATIONAL SECURITY INSTITUTE

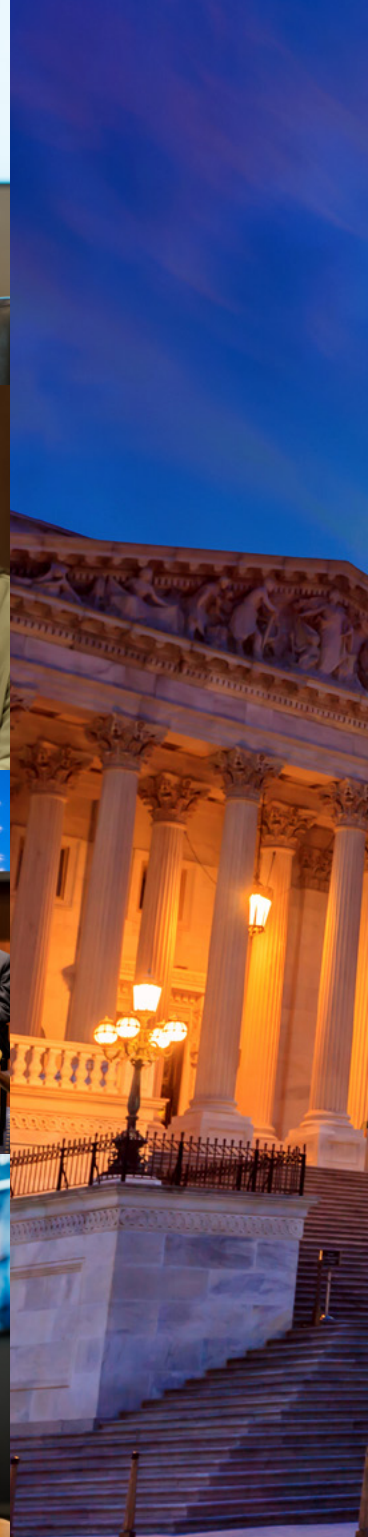
